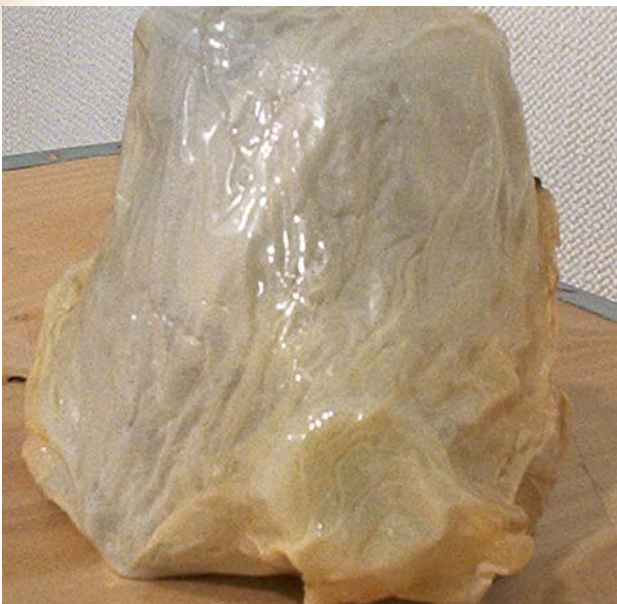

CorShrink™ is a low density polyethylene shrink film adhered to a soft polyester nonwoven fabric impregnated with vapor corrosion inhibitors and a compound that will eliminate electric static discharge (ESD) from occurring. CorShrink™ will form a tight fit around the protected product once heat is applied. CorShrink™ provides a custom fit package along with mechanical protection offered by the soft polyester nonwoven fabric.

CorShrink™ offers contact, barrier and Vapor phase Corrosion Inhibiting (VpCI™) protection.

CorShrink™ is ideal for an application in which the utmost care must be taken when contact is made with the surface and when a custom fit package is needed.
