S-10

PRODUCT DESCRIPTION

S-10 is effective against corrosion in the condensate line of boiler systems. Carbon dioxide is released when feed water containing carbonates and bicarbonates is heated. This carbon dioxide dissolves in water in the condensate line, forming corrosive carbonic acid. S-10 prevents the corrosive action of carbonic acid by neutralizing it as it forms.

S-10, with its high volatility, is carried in the system along with carbon dioxide and steam and neutralizes the acid upon its formation.

DOSAGE

The recommended dosage of S-10 will depend on the amount of carbon dioxide, carbonates and bicarbonates dissolved in the feed water. The pH of the condensate should be maintained between 7.5 and 8.5. Please consult a Cortec representative for a specific recommendation.
